

# REQUEST FOR PROPOSALS WASTE MANAGEMENT SYSTEM

#### BACKGROUND/INTRODUCTION

At Standard Bank Plc we are committed reduce our environmental footprint and promote sustainability. We are looking for a reliable partner to design, implement and manage a tailored waste management solution that meets our specific needs.

We believe that a well-designed waste management system is crucial for minimizing waste, reducing costs and promoting a healthier environment for our employees, customers and the broader community. We are looking for a company that shares our commitment to sustainability and can provide a comprehensive solution that includes, waste separation, waste collection, recycling, composting and reducing waste.

#### SCOPE OF WORK:

- Conduct a waste management audit across our Bank network (Head and Regional
  Office building, 27 branches/service centres across Malawi, ATM locations, and Teller
  implant stations) with the aim of creating a sustainable Waste Management System.
  The system should enable the Bank to track waste disposal (Cradle-to-Grave) and
  report on the waste management process i.e. reuse, recycle, and reduce. It should also
  include the ability to provide data on types of waste, volume, etc.
- The service provider shall provide scheduled and adhoc (for specific functions) waste management services to all points of representation (POR) of Standard Bank which shall include but not limited to:
  - Provide recycling bins
  - Handle the collection of waste from all our PORs
  - Handle climate smart disposal of the waste: reuse, recycle and reduce
  - Offer waste management training to staff and cleaning agents
  - Development of a Waste Information System to track the trend of the various streams of waste disposed and targets achieved for reduction of waste to landfill
  - Upskilling of the cleaning service providers staff in collection of general waste (recyclable and no recyclable) from offices and removal to the onsite waste sorting area for sorting i.e. recycle, reuse or non-recyclable, in preparation for removal from the service provider
  - Keep the records of all general waste that is weighed and shall share on a monthly basis with the bank this information
  - The service provider shall ensure that the business of the Bank is not adversely
    affected by the waste management services.
- The service provider shall handle all forms of waste e.g. E-Waste, solid waste etc aligned
  to the standards, policies and strategies set up by the Ministry of Environmental Affairs
  and Climate Change in Malawi.
